Theme 3

Implementing Pupil Participation

Activity 3(a)

Implementing the National Participation Standards

Purpose

For participants to become familiar with the National Children and Young People's Participation Standards for Wales by considering how they would use them when planning to consult pupils.

Resources

6 copies of [the National Participation Standard posters](#) (available at: <http://www.pupilvoicewales.org.uk/grown-ups/about-us/what-is-participation/>),
or 6 sets of the black and white version of the Standards - photocopied.
A set of Standards Scenario Cards (six scenarios).
6 copies of National Participation Standards Planning Grid.
Powerpoint slide 16: The National Participation Standards.

Preparation

Prepare one set of Scenario Cards.
Download 6 copies of the [National Participation Standards posters](#).
or photocopy 6 sets of the black and white version of the Standards, one for each group.
Photocopy 6 copies of the [National Participation Standards Planning Grid](#), one for each group

Timings

30 minutes.

Participants

Participants work in 6 small groups.

Outline of Activity

Introduce the activity with [Powerpoint 16](#) if you wish.

Divide the participants into 6 small groups.

Give each group a copy of the National Participation Standards **or** a photocopied set of Standards, and a National Participation Standards Planning Grid.

Randomly allocate a scenario card to each group.

Stage 1

Ask each group to read their allocated scenario and decide how they would use the standards when planning the task. They should fill in the planning grid and refer to the standards so they are clear what the standards are and how they can be used as a planning tool.

Stage 2

Ask each group to share their ideas as follows:

- **Group 1** to read their scenario and explain how they will meet the 'Information' Standard.
- **Group 2** to read their scenario and explain how they will meet the 'It's Your Choice' Standard.
- **Group 3** to read their scenario and explain how they will meet the 'No Discrimination' Standard.
- **Group 4** to read their scenario and explain how they will meet the 'Respect' Standard.
- **Group 5** to read their scenario and explain how they will meet the 'You Get Something Out of it' Standard.
- **Group 6** to read their scenario and explain how they will meet the 'Feedback' Standard.

Discuss as a group how they could meet the 'Improving How We Work' Standard.

You can also discuss how this links into the School Effectiveness Framework.

Follow-up

Activity 3b): 'The National Participation Standards and School Self-evaluation'. This activity enables participants to consider how they can use the National Participation Standards as part of their school's annual self-evaluation process, and in preparation for an Estyn inspection.

Activity 3(b)

The National Participation Standards and School Self-evaluation

Purpose

For participants to consider how they can use the National Participation Standards as part of the annual school self-evaluation process, and in preparing for an Estyn inspection.

Resources

Powerpoint Slides 16-17.

One copy of the [National Participation Standards](#) for each group of 4 - 6 (downloadable from <http://www.pupilvoicewales.org.uk/grown-ups/about-us/what-is-participation/>);

or a set of the [black and white version of the Standards](#) for each group - photocopied. ([See Theme 3a](#))

Preparation

Provide one copy of the [National Participation Standards](#) or a set of the [photocopiable version of the Standards](#) for each group of 4 - 6.

Flip chart paper and pens.

Timings

30 minutes

Participants

Participants work in groups of 4-6

Outline of Activity

Show [Powerpoint Slide 16](#): The National Participation Standards

Show [Powerpoint Slide 17](#), containing questions from the Estyn Inspectors' Handbook (2010) relating to the National Participation Standards.

Organise participants into groups of 4-6.

Give each group a copy of the [National Participation Standards](#) (or a photocopiable version).

Ask participants to consider how they might use the National Participation Standards as part of their annual school self-evaluation, or in preparation for an Estyn inspection.

Ask them to discuss the following questions in their groups:

- What could the school do to raise awareness of the National Participation Standards amongst staff and pupils? How could this awareness be evidenced?
- How can schools use the National Participation Standards as part of their school self-evaluation processes, and in preparing for Estyn inspections?
- How can pupils themselves be part of this process?
- How can the increased confidence and skills which come from participation be evidenced?

Ask each group to feedback to the whole group. Make a note of the main points on flipchart.

Follow-up

A self-assessment pack has been developed to help organisations to assess their practice and to collect evidence of how they are meeting the National Participation Standards. This toolkit can be accessed at: <http://www.pupilvoicewales.org.uk/grown-ups/about-us/what-is-participation/>.

Theme 3

Implementing Participation

Activity 3(c)

Barriers and Support

Purpose

To explore some potential barriers to participation, as well as support mechanisms participants think exist in schools when implementing pupil participation.

Resources

Flip chart or white board.

Sets of post-it notes in two colours, one colour for BARRIERS and one for SUPPORT.

[Powerpoint Slide 20.](#)

Preparation

Prepare the flip chart or white board by drawing a line down the middle. Attach one colour post-it with a B to represent BARRIERS on one side of the line and the other colour post-it with S to represent SUPPORT on the other side of the line.

Timings

30 minutes.

Participants

Participants work individually, in small groups, and as a whole group.

Outline of Activity

Give each participant two post-it notes (one of each colour) and explain that they should note the BARRIERS to pupil participation that they think exist in schools on one colour post-it and the mechanisms they think exist in schools to SUPPORT the implementation of pupil participation on the other. (5 - 10 minutes)

Ask each person to place their post-it notes on the prepared flip chart. Read out all of the barriers post-its, grouping post-its with similar points together. Repeat this process for the support post-its. (10 - 15 minutes)

Tell participants that three main barriers to Pupil Participation have been identified in research commissioned by the Welsh Assembly Government (see <http://www.pupilvoicewales.org.uk/grown-ups/about-us/benefits-of-participation/> and Powerpoint Slide 20):

These barriers are:

- Scepticism about children's capacity to have a meaningful input into decision making;
- Worrying that giving children more say will undermine adult authority;
- Compliance will require too much effort that is better spent on education itself.

(Teaching and Learning Research Project - 2010).

Whole-group discussion:

Ask participants:

- Have you identified any of these barriers?
- In your opinion, what can be done to overcome them?

Small Group discussion:

Split participants into groups of four. Ask them to discuss the barriers and suggest ways of overcoming them. (10 minutes)

Ask participants to **feedback to the whole group.** (10 minutes)

Follow-up

Activity 3d): Bricks in the Wall. This activity also explores barriers to Pupil Participation and possible solutions. The barriers generated in the above activity could be used as a starting point, and more detailed solutions drawn out, as a basis for action-planning.

Activity 3f): Action for Participation considers how adults can support effective pupil participation and involves participants in action planning.
